Summary: This rule adds and amends methods as Update III to the Third Edition of the EPAapproved test methods manual SW-846 and deletes several obsolete methods from SW-846 and the RCRA regulations. It also incorporates revisions and amendments from Updates I, II and III into the test methods. This is the fourth in a series of amendments related to the third edition of SW-846. The original rule was promulgated on August 31, 1993 (58 <u>FR</u> 46040). This rule plus the first amendment (September 19, 1994; 59 <u>FR</u> 47980) were included on Revision Checklist 126. The purpose of this fourth amendment is to provide state-of-the-art analytical technologies for RCRA-related testing.

State Authorization: This rule is placed in RCRA Cluster VII. The State modification deadline is July 1, 1998 (or July 1, 1999 if a State statutory change is necessary). These changes do not go into effect until States become authorized for them, because this rule was promulgated under pre-HSWA authorities. Only final authorization is available. The State Revision Application must include applicable regulations, AG statement addendum, Revision Checklist 158, other associated checklists and other application materials, i.e. a program description and an MOA, as determined by the Regional office.

Attorney General's Statement Entry: The following entry should be placed at Subsection I (LL) in the Model Revision Attorney General's Statement.

LL. State statutes and regulations include required test methods in EPA Publication SW-846 and Third Edition of the EPA Approved Test Methods Manual "Test Methods for Evaluating Solid Waste, Physical/Chemical Methods" through Update III and include amendments as indicated in Revision Checklist 158.
