

# **SWIFR for Tribes and Intertribal Consortia: Round 2 Background**

Section I.A. of the NOFO

- EPA is focused on assisting local waste management authorities by supporting improvements to local post-consumer materials management.
- Funding solid waste infrastructure increases recycling, reduces contamination, and promotes a circular economy for sustainable materials management.
- Developing better solid waste management infrastructure and practices reduces climate, environmental, and social impacts of materials use, and keeps valuable resources in use and out of landfills.



### **Funding Opportunity Overview**

# Funding Structure and Period of Performance

Section II of the NOFO

- Total estimated funding for this opportunity is approximately \$20,000,000
- EPA anticipates awarding approximately 20 assistance agreements, with at least one award per EPA region (depending on the quantity and quality of applications received) in amounts ranging from \$100,000 - \$1,500,000 per award.
- Voluntary cost share will not be accepted or evaluated under this competition.
- Estimated start date for projects is March 2026.
- All project activities must be completed within the negotiated project performance period of 3 years.
- Funds may not be used for projects that are already complete and paid for.
- These grants are not PPG eligible.



#### **Scope of Work**

Section I.E of the NOFO

Projects for Tribes and intertribal consortia **must** achieve one or more of the following objectives:

- Develop or update plans focused on encouraging environmentally sound post-consumer
  materials management such as source reduction (e.g., repair clinics, reuse centers), collection,
  storage, transportation, composting, recycling, and/or markets for recyclables;
- Develop, strengthen, and/or implement comprehensive data collection efforts that demonstrate progress towards the National Recycling Goal and Food Loss and Waste Reduction Goal;
- Establish, increase, or expand materials management infrastructure, such as facilities for reuse, recycling or composting; collection and storage bins for recyclable or organic material, purchasing and maintaining equipment or supplies such as scales, crushers, balers, and sorting equipment, trucks, forklifts, and safety equipment);
- Establish or identify end-markets for the use of recycled materials; or
- Demonstrate an increase in the diversion recycling rate, and/or quality of materials collected.



#### **Types of Eligible Projects**

Section I.E of the NOFO

Projects may include (but are not limited to) projects that fund:

- Developing or updating plans focused on improving post-consumer materials management;
- Planning and construction of facilities for food recovery, reuse, recycling, composting or anaerobic digestion;
- Programs that provide or increase access to prevention, reuse, and recycling in areas that currently do not have access; including construction of and/or upgrades to drop-off and transfer stations (including but not limited to a hub-and-spoke model in rural communities);
- Purchasing collection or storage bins for recyclables or organic material;
- Purchasing or leasing recycling equipment or supplies for post-consumer materials management recovery efforts (e.g., crushers, balers, and sorting equipment, trucks, forklifts, safety equipment);
- Activities focused on development of end-markets for materials (e.g., working with a recycler to accept collected materials for processing);
- Activities to support increasing and improving collection of recyclable materials and/or organics and food waste, and backhaul;



# Types of Eligible Projects (continued)

Section I.E of the NOFO

- Activities to reduce, reuse and recycle building materials including deconstruction (dismantling buildings for reuse and recycling) and construction and demolition debris recycling equipment and projects;
- Activities focused on reducing contamination in the recycling stream;
- Training, technical assistance, and/or tools required to plan, establish, or implement post- consumer materials recovery (e.g., applicants may apply for funding for training employees on use and safety of recycling equipment, raise awareness of infrastructure and processes);
- Education and outreach activities relating to post-consumer materials management;
- Land acquisition when necessary for construction for improvements to tribal recycling facilities and waste management facilities subject to the requirements 2 CFR 200.311 and 2 CFR 200.316; and/or
- Other activities that the applicant believes will further the objectives of the NOFO.



#### **Ineligible Costs**

Section III.E of the NOFO

- Landfilling, incineration, burn units, waste-to-energy (except anaerobic digestion), gasification, chemical and thermal recycling, biofuels, and environmental cleanup are <u>not</u> eligible for funding under this solicitation. Food processing is only eligible when paired with recycling activities.
- <u>Surveys</u>: EPA funds cannot be used to design nor administer the collection of identical information from 10 or more parties (for example, through surveys or focus groups).
  - Reasonable costs for analyzing and publishing the independently collected information are allowable to the extent authorized in the EPA approved budget for this agreement.
- All costs must meet the requirements for allowability in 2 CFR Part 200, Subpart E and applicable provisions of 2 CFR Part 1500.
- <u>State and local government bonds:</u> SWIFR cooperative agreement funding "... **may not be used (directly or indirectly) as a source of payment** (in whole or in part) of, or security for, an obligation the interest on which is excluded from gross income under section 103 of Title 26" of the United States Code (as provided in 33 U.S.C. 4282(f)).





### Requirements

#### **Eligible Entities**

Section III.A of the NOFO

#### **Entities eligible to apply:**

- Federally Recognized Tribes, which include Alaskan Native Villages as defined in Public Law 92-203, and former Indian reservations in Oklahoma, as determined by the Secretary of the Interior, and
- Intertribal consortia, consistent with the requirements in 40 CFR 35.504(a).
  - Intertribal consortia must submit documentation demonstrating that all members of the consortium meet the eligibility requirements and authorize the consortium to apply for and receive assistance.

#### **Entities not eligible:**

- States and Territories
- Individuals
- For-profit and non-profit organizations



#### **SWIFR Round 1 Grant Recipients**

- The EPA may consider prioritizing applicants that:
  - have not previously received SWIFR grants, or
  - those that previously received SWIFR grants and have disbursed at least 25% of the funding for each SWIFR cooperative agreement they have with EPA by January 15, 2025.





#### **Coalitions**

Section I.C of the NOFO

- **Groups of two or more eligible applicants** (see *Section III: Eligibility Information*) may choose to form a coalition and submit a single application under this NOFO.
  - A coalition is different from an intertribal consortium.
- One entity must be responsible for the grant (i.e., the grantee/lead applicant), and the other entities would be brought on via subawards.
- Coalitions must identify which eligible organization will be the recipient of the grant and which eligible organization(s) will be subrecipients.



#### **Threshold Eligibility**

Section III.C of the NOFO

- 1. Address at least one of the mandatory grant objectives in Section I.E: Scope of Work.
- 2. Eligible entity, as described in Section III.A: Eligible Applicants.
- 3. Federal funds requested must be between \$100,000 and \$1,500,000.
- 4. Funds awarded under this NOFO may not be used to carry out the same activities that are already funded or in the process of being funded under other EPA financial assistance programs such as the Indian General Assistance Program, Tribal Hazardous Waste Management Grant Program, and the Tribal Response Program Grants or financial assistance applicants receive from other Federal agencies. Applicants must provide a statement that their proposed project(s) do not duplicate other Federally funded grants received.



#### Threshold Eligibility (continued)

Section III.C of the NOFO

- 5. Substantially comply with the application submission instructions and requirements set forth in Section IV: Application and Submission Information.
- Submit application through Grants.gov (except in limited circumstances where another mode of submission is specifically allowed for, as explained in Section IV.C: Technical Issues with Submission).
- 7. Applications submitted outside of Grants.gov or after the submission deadline will be considered late and deemed ineligible without further consideration unless the applicant can demonstrate it was due to EPA mishandling or because of technical problems associated with Grants.gov or relevant SAM.gov system issues.

#### **Project Narrative Attachment Form**

- Must provide factual information about your proposed project. Do not include discussions of broad principles that are not specific to the proposed work or project covered by your application.
- Responses to evaluation criteria should include the criteria number and title but need not restate the entire text of the criteria.
- Provide sufficient detail to allow for an evaluation of the merits of the proposal.
- Vague descriptions, redundancy, and failure to address each of the evaluation criteria will result in a lower ranking.

### **Evaluating Applications**

#### **Evaluation Criteria**

Section V.A of the NOFO

- Eligible entities whose applications meet the Threshold Criteria will be reviewed according to the evaluation criterion set forth in the following slides.
- Each application will be rated under a points system, with a total of 100 points possible.
- Applicants may, but are not required to, use the Optional Templates for the Summary Information Cover Letter, the Narrative Proposal and the Budget Table & Description.

### Section V.A. of the NOFO

# Criterion 1: Project Summary & Approach (40 points)

- The Narrative Proposal includes a clearly written description of the overall project.
- b. The project meets the requirements in *Section I.E: Scope of Work.*
- c. The Narrative Proposal clearly identifies the goals and objectives of the project and includes an effective, easily understood plan with well-reasoned steps and milestones to meet the stated objectives.
- d. The Narrative Proposal sets forth a reasonable time schedule for the execution of the tasks associated with the project and for achieving the project goals and objectives by project end.



## Criterion 2: Impactful Approaches & Solutions (25 points)

Section V.A. of the NOFO

- a. Describe how the project results will improve the environmental conditions of the Tribal community(/ies) in the short and long term (including reducing greenhouse gas emissions), and any other community benefits associated with the anticipated project outcomes.
- Describe how the anticipated benefits of the project contribute to post-consumer materials management in Tribal communities.

#### Impactful projects may include, but are not limited to:

- solving local challenges around collection of materials in rural or isolated areas;
- operations or activities fostering environmentally sound materials management to multiple Tribes;
- coordinating regional source reduction, recycling or backhaul services;
- establishing or expanding a hub and spoke source reduction and/or recycling system;
- projects that will result in a significant decrease in greenhouse gas emissions;
- projects that will increase the long-term climate resilience of Tribal post-consumer materials management systems.



# Criterion 3: Measuring Environmental Results (10 points)

Section I.H. & Section V.A. of the NOFO

- Propose strategies for measuring and tracking the expected outputs and outcomes described in Section I.H: Measuring and Reporting Environmental Results: Outputs and Outcomes.
- Outputs and outcomes must be quantitative or qualitative, and should be directly linked to a measure of environmental improvement and to project activities described in the Narrative Proposal.
- Please note that **all outputs and outcomes** listed in *Section I.H: Measuring and Reporting Environmental Results: Outputs and Outcomes* must be discussed to receive full points for this criterion (even if the anticipated result is "0" or "Not Applicable").



# Criterion 3: Measuring Environmental Results: *Outputs and Outcomes*



- Number of infrastructure investments/enhancements made spanning the spectrum of collection through end market development (e.g., bins purchased, post-consumer materials management systems created, technology improvements made).
- Tons of MSW/C&D collected, recycled, or composted, or managed via each relevant management pathway in the community served by the project.
- Tons of MSW/C&D generated per material type (e.g., plastic, food waste, etc.) and source in the community (e.g., household, school, or business) served by the project.
- Number of temporary or permanent jobs created (including part-time).
- GHGs reduced (in MTCO2e) from collection, recycling, composting or management via other management pathways.
- Percentage of Tribes and Tribal members of intertribal consortia served as a result of establishing, increasing, expanding, or optimizing collection.
- Number of Tribes and member Tribes of intertribal consortia served as a result of establishing, increasing, expanding, or optimizing collection.



# Criterion 4: Programmatic Capability & Past Performance (10 points)

Section IV.E and V.A. of the NOFO

- **Past performance** in successfully completing and managing the assistance agreements identified in response to *Section IV: Application and Submission Information* of the solicitation.
  - a. Section IV requires applicants to **submit a list of federally and/or non-federally funded assistance agreements** that your organization performed within the last three years (no more than 5 agreements, and preferably EPA agreements).
- **b. History of meeting the reporting requirements under the assistance agreements** identified in response to *Section IV: Application and Submission Information* of the solicitation including whether the applicant submitted acceptable final technical reports under those agreements and the extent to which the applicant adequately and timely reported on their progress towards achieving the expected outputs and outcomes under those agreements.
- c. **Staff expertise/qualifications** (including organizational experience), staff knowledge, and resources or the ability to obtain them, to successfully achieve the goals of the proposed project.

If you do not have any relevant or available past performance or past reporting information, please indicate this in the application and you will receive a neutral score for these subfactors.

If you do not provide any response for these items, you may receive a score of 0 for these factors.



# Criterion 5: Budget & Expenditure of Awarded Grant Funds (15 points)

Section V.A. of the NOFO

Applications will be evaluated based on their approach, procedures, and controls for ensuring that awarded grant funds will be expended in a timely and efficient manner. The Agency will evaluate the proposed project budget and narrative to determine the extent and quality to which:

- a. Costs are reasonable to accomplish the proposed goals, objectives, and measurable environmental outcomes.
- b. The proposed budget provides a detailed breakout of the approximate funding used for each major activity.
- c. The application conveys the approach, procedures, and controls for ensuring that awarded grant funds will be expended in a timely and efficient manner.

Provide the response to this criterion as part of your budget table and description. (See optional budget table and description spreadsheet resource provided on <u>EPA's Solid Waste Infrastructure for Recycling Grants for Tribes and Intertribal Consortia</u> webpage.)

#### 2 CFR Part 200 Updates

- OMB updated the Uniform Grants Guidance (2 CFR Part 200) <u>earlier this</u> <u>year</u>. The changes are **effective October 1, 2024** and include updates relevant to SWIFR grants.
