e-Manifest Third Rule Compliance Dates

- There are 2 important dates.
 1. **January 22, 2025** – rule effective date (6 months from when the rule was published in the Federal Register)
 2. **December 1, 2025** - delayed compliance date for changes that require e-Manifest system updates.
- All requirements will become effective at one of the two dates.
- Changes marked with the  symbol will go into effect in **January 2025**.





Effective January 22, 2025

- LQGs and SGGs must register for e-Manifest
- Users required to make post-receipt manifest corrections
- Removal of the requirement for RCRA receiving facilities to provide final manifests to LQGs and SQGs
- Adjustment to submission timeframe for manifest-related reports
- Form changes
 - 4-copy manifest
 - International shipments field
- Conforming changes to TSCA/PCB manifest requirements

Effective December 1, 2025

- Requirement to submit manifest-related reports through e-Manifest system
 - Exception
 - Discrepancy
 - Unmanifested waste
- Requirement for exporters to submit export manifests to e-Manifest and pay user fee

Revised/New FAQs

- We have posted new FAQs to the e-Manifest FAQ webpage to reflect changes to the manifest requirements finalized in the e-Manifest Third Final Rule
- We have also posted new FAQs for PCB generators registering for access to e-Manifest
- Some of the new posted FAQs include:
 - Discussion regarding the 4-copy manifest forms and continued use of 5-copy manifest forms after January 22, 2025
 - Record retention policies for PCB wastes tracked with the RCRA manifest
 - Applicability of the manifest to non-TSCA PCB waste/state-regulated PCB wastes

e-Manifest Advisory Board Updates

- Last e-Manifest Advisory Board Public Meeting Held on September 17-18, 2024.
Meeting Theme: Meeting the Needs of the User Community: e-Manifest Program Priorities and User Fees for Fiscal Year 2026 and 2027"
- e-Manifest Advisory Board Recommendations Published on December 10, 2024

- EPA is currently reviewing recommendations, and the Agency will subsequently respond to the recommendations.

Setting to Scheduled Updates

- Receiving Facilities may allow Generators, Transporters, and Brokers to set manifests to Scheduled
 - This will allow Generators and Transporters to create and then immediately sign manifests with out needing to request the Receiving facility to set it to scheduled.
- **New** Site Settings (under the "Other Actions" dropdown

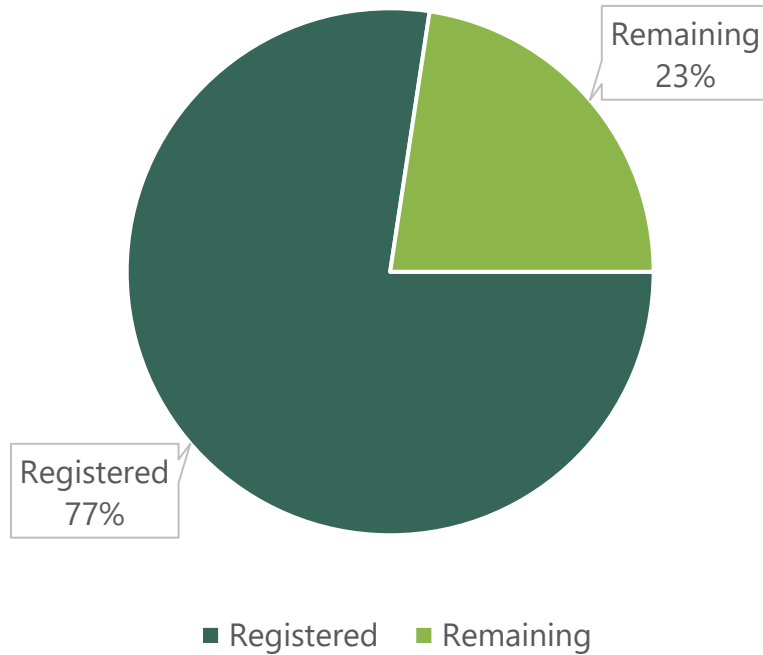

Mandatory LQG/SQG Registration

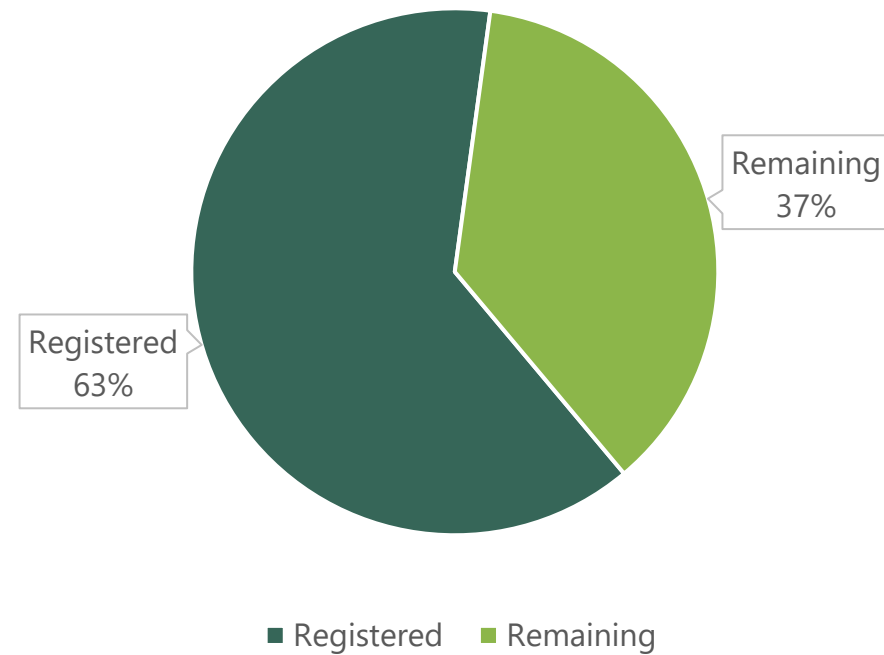


e-Manifest

Mandatory SQG/LQG Registration

- Sign up and request site access
 - [How to register video](#)
- **SQGs and LQGs must have at least one user with e-Manifest access**
 - Certifier (in the e-Manifest module) or Site Manager access is required to submit the manifest-related reports and make data corrections
- [e-Manifest Third Rule Compliance Check](#)
 - Download a list of all RCRAInfo sites that have notified as an LQG or SQG that do not have a registered Site Manager or Certifier in RCRAInfo.
- VSQGs and PCB-exclusive generators are not required to register
