Rescinding Request to Terminate Permit – Canceling Termination of Permit**

Dear Mr. Jackson:

By this letter, the Department of Environmental Protection (Department) is canceling its termination of the above-mentioned permit that was last issued on October 10, 2018 to East Coast Seafood Group d/b/a Maine Fair Trade Lobster for the Gouldsboro facility. It is our understanding that the request to terminate from Maine Fair Trade Lobster dated August 17, 2021, was submitted during a time of internal miscommunication and that the permittee (Maine Fair Trade Lobster) presently objects to the termination of the permit. This was explained to me via a phone call from you on August 23, 2021 and then confirmed with email communication on that day.

The Department will cancel any current actions that would inactive the facility in our database so that Discharge Monitoring Reports and billing statements continue to be sent to you in the future. By copy of this letter, we are notifying the U.S. Environmental Protection Agency of the request to rescind retirement of the license.
