Dear Mr. Mohlin:

By this letter, the Department of Environmental Protection (Department) is terminating the above referenced permit last issued on November 2, 2015 to Evonik Cyro LLC for their facility in Sanford, Maine. The permit authorized the discharge of 0.300 MGD of non-contact cooling water from an industrial manufacturing facility to the Mousam River, Class C.

Based on a letter attached to an email dated July 29, 2021 from you to me, it is our understanding you are requesting to terminate said WDL/MEPDES permit on behalf of the owners (Roehm America LLC). On November 30, 2021, the Department's Compliance Inspector for this site, Matt Hight, emailed me confirmation that the discharge pipe has been permanently sealed and that no wastewater is able to be discharged to the Mousam River from this site.

The Department will be inactivating the facility in our database so that Discharge Monitoring Reports and billing statements are not sent to the permittee in the future. By copy of this letter, we are notifying the U.S. Environmental Protection Agency of the retirement of the permit.

Please be advised that a new permit may be needed from Department for any future discharge of pollutants from this facility to the surface or ground waters of the State of Maine, either under current ownership or new ownership. Any new permit/license would be based on the characteristics of the effluent being discharged and the impacts of the discharge on the quality of the receiving water.
