

TYPE OF FACILITY: Manufacturing

The facility, which has been the source of a wastewater discharge, was issued a permit to discharge on March 19, 2019 and is due to expire on May 1, 2024. This facility was engaged in the manufacturing of electronic connectors. The permit pertains to 2 discharges consisting of Non-Contact Cooling Water (NCCW) from Outfall 001 and filter backwash from a groundwater filtration system that is used to pretreat well water prior to use in the NCCW system from Outfall 002. The discharge points are no longer active since November 9, 2020. The facility now utilizes a closed loop chiller system and has disconnected the NCCW system and capped the point source.

BASIS FOR DEM'S TENTATIVE DECISION TO TERMINATE:

The permittee is no longer discharging to a water of the state, having ceased discharge as of November 9, 2020.
