We have received the FY2025 Appropriations and a final operating plan and we have calculated the Underground Injection Control State and Tribal Grant allotments for FY2025. The state-by-state allotments are based on the final budget of \$12,277,000 and are attached. This is a \$17,000 decrease from the previous fiscal year's budget. Consistent with grant regulations found in 40 CFR 35.192, these allotments were based on population, geographic area, extent of underground injection practices, and other relevant factors.

State and Tribal grant recipients are expected to implement their programs to help achieve the priorities specified in this memo. The overall objective of this grant program is to protect public health by enforcing minimum requirements to ensure that:

- All injection is authorized under general rules or specific permits;
- Injection well owners and operators do not site, construct, operate, maintain, convert, plug, abandon, or conduct any other injection activity that endangers an underground source of drinking water;
- Injected fluids stay within the well and the intended injection zone; and
- No injection occurs which allows for the introduction of any contaminant into an underground source of drinking water if the presence of that contaminant may cause a violation of any primary drinking water standard or otherwise adversely affect public health.

To assist owners and operators of UIC facilities in meeting these objectives, grantees should consider a variety of approaches and coordinate efforts with other groundwater protection programs. FY2025 priority activities for the UIC grant fund recipients include:

- Maintaining program capacity to implement UIC program requirements for all classes of wells;
- Ensuring that Class I, II, and III (salt solution) wells that lose mechanical integrity are returned to compliance;

- Addressing high-priority Class VI wells; and
- Submitting data through the EPA's UIC Data Application.

When you negotiate workplans/grant agreements for your primacy states and tribes you should ensure that the state/tribal programs are focused toward achieving the goals outlined above. As in previous years, regions may provide non-direct implementation funds to states and tribes that have primacy to implement and maintain UIC programs.

In accordance with EPA Order 5700.6A2, *Policy on Compliance, Review and Monitoring*, effective January 1, 2008, EPA regions must develop and carry out a post-award monitoring plan and conduct baseline monitoring for every award. This monitoring should ensure satisfaction of five core areas: (1) compliance with all programmatic terms and conditions; (2) correlation of the recipient's workplan/application and actual progress under the award; (3) availability of funds to complete the project; (4) proper management of and accounting for equipment purchased under the award; and (5) compliance with all statutory and regulatory requirements of the program.
