Re: Monitoring Closure of EPA Complaint No. 01CR-20-R1

Dear Secretary Tepper:

This letter is to notify you that the U.S. Environmental Protection Agency (EPA) Office of External Civil Rights Compliance (OECRC) has determined that the Massachusetts Executive Office of Energy & Environmental Affairs (EEA) has fully complied with the terms under the Informal Resolution Agreement (Agreement), dated January 12, 2024, between EEA and OECRC, relating to EPA Complaint No. 01CR-20-R1. Accordingly, OECRC is closing the monitoring of the Agreement and the Complaint as of the date of this letter.

Pursuant to Section III of the Agreement, EEA has submitted, and OECRC has reviewed, reports and website updates demonstrating completion of deliverables. On July 18, 2025, by email, EEA notified OECRC that it had fulfilled its final commitment by ensuring that all staff and contractors, as appropriate, have been trained on the policies, processes, and procedures established by Section III of this Agreement. By satisfying the EEA Training commitment (see Section III (E)(1)(d)), EEA has fulfilled its commitments as set forth in Section III of the Agreement.

Neither the closure of the monitoring or closure of the Complaint affects EEA's continuing responsibility under Title VI, 40 C.F.R. Parts 5 and 7, and, as applicable, other federal nondiscrimination laws, 1 nor does it affect EPA's investigation of any Title VI or other federal
