The Massachusetts Department of Environmental Protection, Division of Watershed Management, has reviewed the notice of intent to be covered under the General Permit for Construction Dewatering Facilities (<http://www.epa.gov/region1/npdes/dewatering.html>) for the above referenced application.

The Department concurs that this project should be authorized to discharge under the permit to the Neponset River, a Class SB waterbody in the area of the discharge.

The duration of the discharge is expected to last until April 2011 through three outfalls. Grab samples are to be collected for Total Suspended Solids (TSS) and pH. Oil & Grease analysis is required only upon the detection of a visible sheen. (See General Permit Part 1.2.6). The maximum daily limit for TSS is 100 mg/l and the monthly average limit for TSS is 50 mg/l. The limit for pH is 6.5-8.5 (or natural background values).

The applicant should note only TSS and pH are covered under this General Permit. A groundwater remediation general permit should be obtained from the Environmental Protection Agency to discharge wastewater containing significant quantities of any other pollutants.
