RE: Ledvance, LLC in Waldoboro, ME - Permit Retirement, Maine Pollutant Discharge Elimination System (MEPDES) ME0002381 & Waste Discharge License (WDL) #W000714-S-J-R

Dear Ms. Garvey:

This letter is to confirm that the Maine Department of Environmental Protection will retire the Waste Discharge License (WDL #W000714-5S-J-R) and withdraw the application for permit renewal (WDL #W000714-5S-K-R) for LEDVANCE LLC in Waldoboro, Maine.

On September 10, 2021 the Department accepted as complete an application for the renewal of combination Waste Discharge License (WDL) #W000714-5S-J-R / Maine Pollutant Discharge Elimination System (MEPDES) permit #ME0002381 (permit hereinafter) which was issued by the Department on September 7, 2016, and authorized the discharge of a monthly average of 10,000 gallons of treated ground water to the Medomak River, Class SB, in Waldoboro, Maine. The permit has been administratively continued since September 7, 2021, awaiting further Department action.

The site formerly owned by LEDVANCE, LLC in Waldoboro, Maine, ceased discharging in 2023, but the permittee continues to monitor ground wells on site in conjunction with the Bureau of Remediation and Waste Management.

A site visit conducted on October 15, 10-15-2025 confirmed that a wastewater discharge no longer occurs, and at this time a Waste Discharge License is not necessary. On November 5, 2025, the Department received via email confirmation that the permittee would like to retire the license.

If future conditions change and it becomes necessary for LEDVANCE LLC to resume discharging treated groundwater, the Department of Environmental Protection will consider a General Application for a Wastewater Discharge to determine appropriate parameter limitations and testing frequencies.
