1. Shawsheen River (MA83-19): Curly-leaf Pondweed, Fish passage barrier, and Benthic Macroinvertebrates were added.
2. Shawsheen River (MA83-19): Changed from a category 4A to 5 Impaired Water.

No further changes to the Integrated List have been noted during PY6.
